Fire Technical Council (FTC) is still dealing with **the following STANDATA which will affect Electricians:** **1)** Elevator upgrade issues concerning addition of smoke detection are ongoing but far from complete and attention needs to be kept on this issue. **2)** The problem with Alarm upgrade requirements when updating a panel (sometimes caused by Elevator upgrades) is not yet complete. This sorts the problem with Alarm upgrades being done in some cases to the 1981 Building Code, and that code is not available in the Library or the City archives any longer. **3)** "All fire detection within a building **MUST** be routed through the main annunciator panel", this effectively prevents a smoke alarm being installed as part of a separate security system within a building which has a fire alarm panel.

Thank you to Keven Lefebvre, PEC as he ends his 9 year term with the Fire Technical Council (FTC). **Congratulation Peter Wemyss** (Simplex Grinnell) on his appointment as the new ECAA representative to sit on the FTC.

Electrical Technical Council (ETC) still working with Grant Thornton on OBIEC. An

overwhelming amount of questions were submitted by members with regards to the Grant Thornton report and some will remain unanswered until more details are sorted out in the process. It was reported that two CSA Standards are available relative to OBIEC, however they are not yet adopted in Alberta. **A Master's Advisory Group is being formed;** Kevin Harrison (NAIT) has been selected as the Chair. Currently Safety Codes Council is seeking representatives for this group.

Continuing Education

February 9 & 10, 2012 - Legal Implications. The instructors for this course are from the legal firm of Fraser Milner Casgrain, LLP. This course will address such matter as incorporation, income tax and GST, construction contracts and subcontracts and liability thereunder, and perhaps most importantly, steps available to ensure payment, including remedies under the Builder's Lien Act. Liability in stamping and sealing drawings will also be addressed.

February 23rd & 24th - Basic Electrical Estimating (Edmonton) Course Full. If you would like your name to be put on a waiting list please email bsmith@ecaa.ab.ca For small contractors who are not ready to make the investment in a computerized estimating system. Designed to teach new contractors the fundamentals of preparing an electrical estimate using the Elemental Format hands-on. The course will address material take-off, pricing of materials, labouring of materials using the NECA Manual of Labour Units, labour costs, special overheads, general overheads and profit/contingencies.

March 8th & 9th - Computer Estimating (Edmonton) This course is designed to provide the new estimator or contractor with a basic understanding of how to prepare an estimate. It covers: Planning for the estimate; Preparing counts, take-

offs; Preparing the Bill of material for supplier pricing and Review of the Bill of material; Accubid "Bidwinner"; Use of assemblies, where to enter miscellaneous costs, supplier pricing, overhead costs, and the final pricing sheet; Use of Excel spreadsheets to assist with take-offs.

March 23rd & 24th - Safety Principles (Calgary) A well developed safety program can reduce costs resulting from injury and property damage, and is the hallmark of a quality electrical contracting firm.. The first day of the course shows you each step to develop and implement an effective safety program for your small to medium sized electrical contracting firm. The next day is designed to help managers ensure construction supervisors fine-tune their safety skills by: clearly understanding what their safety roles and responsibilities are; presenting and delivering effective training to workers and maintaining high worksite safety standards; conducting effective site inspections - and developing appropriate recommendations; investigating - the steps to follow and processes involved.

ELECTRICAL SAFETY TRAINING SYSTEM (ESTS) is a computer based, distance delivered program that recognizes Provincial & Federal Occupational Health & Safety Regulations.
